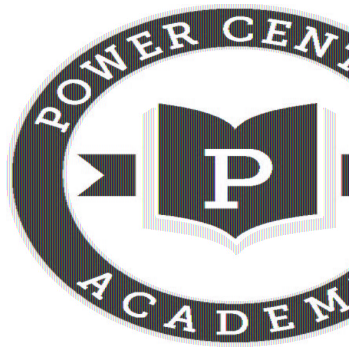

Title I

Power Center Academy Elementary School- Hickory Hill campus qualifies to receive federal funds under the No Child Left Behind Act of 2000, Title 1, Part A, for the 2022-2023 school year. Schools may consolidate and use funds under Title I, together with other federal funds, in order to upgrade the entire educational program in schools in which not less than 40% of the children enrolled from low- income families. Our Title I program will provide parents with opportunities throughout the year to learn how to help their child/children academically. A Title I Parent meeting is held during Orientation/ Back to School Nights to inform parents of the components of the program.

- come to school on time, everyday with supplies needed for classroom work

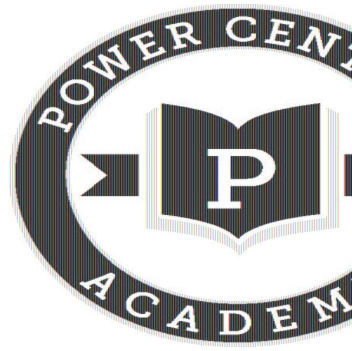


Title I Compact Teacher Responsibility

Supporting Scholars Attendance

- Ensure scholars are at school daily and on time.
- Scholars are tardy at 8:30am but school starts at 7:50am!
- All **excuse notes for any absences must** be emailed to pcaeshh@powercenteracademy.org
- All excuse notes must be submitted within **3 days** of any absence.
- A picture of a doctor's note **must** be submitted in order to excuse 3 or more consecutive days.



Let's Not Forget about Attendance Truancy

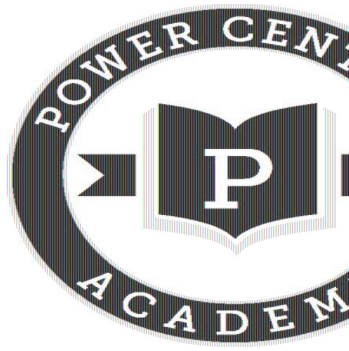
5+	5-Day Notification letter with reference to the truancy laws and consequences of noncompliance. Parents must attend a meeting with school's designee to develop a school attendance plan (1). Scholar Attendance Review Team (SART) is held on a specified day at each school. All attendance records are held at the school level. Report to SCS representative. Designated secretary sets meeting aligned to designated AIP meeting days set by the Dean of Scholar.
10-14	10-Day Action letter with reference to the truancy laws and consequences of noncompliance. GCS designee will be notified. A member of Attendance Review Committee (ARC) makes the Department of Children Services call for noncompliance and document the call in PowerSchool on the Truancy page. A report is sent to SCS representative.
45+	Scholar is eligible for retention to current grade. Memphis City District Court will take further legal action. Director of Academic Operation and Support will update the school's principal and designees. Scholars are not eligible to participate in any school athletic teams, organizations or field trips.



Supporting Scholars Learning

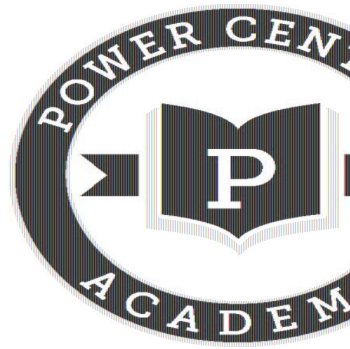
- Allow scholars to try their best independently before supporting them

Survey for Attendance

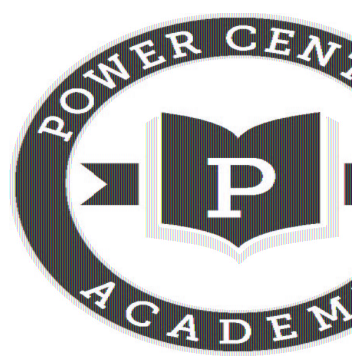
