



***Title I Family Engagement Plan 2024-2025***

*Title I regulations require that each school served under Title I jointly develop with and distribute to parents of participating children, a written parental involvement policy agreed on by the parents that describes the requirements of (c) through (f) as listed below and outlined in Title I law:*

***A. Policy Involvement***

*Each school served under this part shall –*

*1. *PCAHS-HH will involve parents in the Title I planning process during the*

*monthly Parent Advisory Council (PAC) Meetings. Parents will meet monthly to review programs and determine changes that need to be made. If the schoolwide improvement plan is not agreed upon, the school will include comments from families once the plan is made available to the public.*

*4. Provide parents of participating children –*

- iii. if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practically possible.*

*PCAHS-HH will share the above information during the Annual Title I Meetings with families.*

*5. If the school-wide program plan is not satisfactory to the parents of participating children, submit any parent comments on the plan when the school makes the plan available to the local educational agency.*

*Parents can email all school - wide program plan comments to the principal. The principal or her designee will follow - up with the parent and work to address the concern.*

*D. Building Capacity for Involvement*

*To ensure effective involvement of parents and to support a partnership among the school*

*a. *PCAHS-HH will share the above information during the Annual Title I Meetings with families. PCAHS-HH will also provide opportunities throughout the school year, including PAC Meetings and parent - school conferences, to discuss academics with parents.*

*PCAHS-HH will provide parent training sessions throughout the school year during parent meetings. Additional training is available upon request.*

Shall educate teachers, pupil services personnel, principals, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school;*

*PCAHS-HH will provide professional development on customer service to staff during the summer staff orientation.*

*d. *PCAHS-HH will provide a parent resource area in which parents can access necessary resources and assistance as needed.*

*PCAHS-HH will send home hard copies of the monthly newsletter in English and Spanish. In addition, the monthly newsletter will be emailed to all parents in English and Spanish.*

*f. May involve parents in the development of training for teachers, principals, and other educators to improve the effectiveness of such training;*

*g. May provide necessary literacy training from funds received under this part if the district has exhausted all other reasonably available sources of funding for such training;*

*h. May pay reasonable and necessary expenses associated with local parental involvement activities, including transportation and child care costs, to enable parents to participate in school-related meetings and training sessions;*

*i. May train parents to enhance the involvement of other parents;*

*j. May arrange school meetings at a variety of times, or conduct in-home conferences between teachers or other educators, who work directly with participating children, with parents who are unable to attend such conferences at school, in order to maximize parental involvement and participation;*

*k. May adopt and implement model approaches to improving parental involvement;*

*l. May establish a district parent advisory council to provide advice on all matters related to parental involvement in programs supported under this section;*

*m. May develop appropriate roles for community-based organizations and businesses in parent involvement activities; and*

*n. Shall provide such other reasonable support for parental involvement activities under this as parents may request.*

*Members of the PCAHS-HH Parent Advisory Committee (PAC) will meet monthly to determine opportunities for all stakeholders to be further trained.*

#### *E. Accessibility*

*In carrying out the parental involvement requirements of this part, districts and school, to the extent practicable, shall provide full opportunities for the participation of parents with children with limited English proficiency, parents with children with disabilities, and parents of migratory children, including providing information and school reports in a format, and to the extent practicable, in a language such parents can understand.*

*Las normas del Título I exigen que cada escuela atendida bajo el Título I desarrolle y*

*distribuya conjuntamente a los padres de los niños participantes, una política de participación de los padres por escrito acordada por los padres que describa los requisitos de (c) a (f) como se enumeran a continuación*

*y se describen en la ley del Título I:*

*Participación en la política*

*Cada escuela atendida bajo esta parte deberá:*

*1. Convocar una reunión anual, en un horario conveniente, a la que se invitará y alentará a todos los padres de los niños*

*participantes a asistir, para informar a los padres sobre la participación de su escuela bajo esta parte y para explicar los requisitos de esta parte y el derecho de los padres a participar;*

*El director de PCAHS-HH será responsable de programar las reuniones anuales del Título I antes del 15 de septiembre.*

*2. Ofrecer una cantidad flexible de reuniones, como reuniones por la mañana o por la tarde, y*

*podrá proporcionar, con los fondos provistos bajo esta parte, transporte, cuidado de niños o visitas*

*a domicilio, ya que dichos servicios se relacionan con la participación de los padres;*

*PCAHS-HH ofrecerá una Reunión Anual del Título I por la mañana y por la tarde cada año.*

*PCAHS-HH involucrará a los padres en el proceso de planificación del Título I durante las*

*El director o su designado se comunicará con el padre y trabajará para*

*abordar la inquietud. Responsabilidades compartidas para el alto rendimiento académico de los estudiantes*

*Como componente de la política de participación de los padres a nivel escolar, cada escuela deberá*

*desarrollar conjuntamente con los padres para todos los niños atendidos bajo esta parte un pacto entre la escuela y los padres que*

*establezca cómo los padres, todo el personal de la escuela y los estudiantes compartirán la responsabilidad de mejorar el rendimiento académico de los estudiantes.*

*PCAHS-HH preparará conjuntamente el pacto entre la escuela y los padres durante la*

*Reunión del Comité Asesor de Padres antes del 29 de septiembre.*

*Realizar reuniones trimestrales de datos para que los padres vean el crecimiento académico de los estudiantes en toda la escuela*

*Desarrollar la capacidad para la participación*

*a.
